Agencies which fail to remit monies within 30 days but do so within 60 will get only 10% Commission; those paying after 60 days but within 90 days will get only 5% commission, while those paying after 90 days but within 120 days get no commission at all. Agencies that owe beyond 120 days will be charged interest on the amount outstanding at the prevailing CBN interest rates.
